This position directs all financial activities, including budget development, audits, utility billing, payroll, debt management, and investment oversight. The Finance Manager also supervises office personnel and leads internal controls to safeguard ratepayer resources. #### **Key Responsibilities:**

- Develop and administer annual budget in compliance with GAAP, GASB, and Oregon Local Budget Law.
- Prepare financial reports, oversee audits, and ensure regulatory compliance.
- Supervise accounting, payroll, billing, collections, and investment management functions.
- Lead financial planning and forecasting in coordination with the General Manager and Board.
- Oversee customer service operations and staff performance.
- Participate in rate-setting processes and capital project financing, including bond management.
- Evaluate and improve financial software systems and processes for efficiency.

- Bachelor's degree in accounting, finance, public administration, or a related field.
- A minimum of seven (7) years of progressively responsible experience in financial management, including at least three (3) years in a supervisory role.
